1. Welcome and Introductions.

PRESENTATION

2. Charles Marsh, P.E., Project Director, Weaver Consultants Group, LLC, will brief the Subcommittee on the Type IV major permit amendment application for the Fort Worth C&D Landfill in Tarrant County.

Mr. Marsh stated that the facility is located in southeast Tarrant County. In its 30 years of existence, this is the fourth amendment for this facility. This amendment proposes to expand the waste disposal footprint by 22 acres, and increase the height by 40 feet mean sea level. The expanded site life is expected to be about 13 to 20 years.

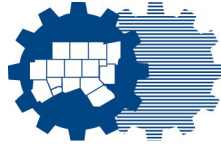
3. The Subcommittee will discuss the Type IV major permit amendment application for the Fort Worth C&D Landfill, and vote whether to recommend to the Resource Conservation Council (RCC) that the application conforms to the North Central Texas Regional Solid Waste Management Plan.

There was one question from the Subcommittee:

- 1) Do you have a special area set aside for green waste?

No, but that is something that is constantly being evaluated.

Chris Hoofnagle, City of Garland, made a motion to recommend to the Resources Conservation Council that the major permit amendment application for the Fort Worth C&D Landfill conforms to

the North Central Texas Regional Solid Waste Management Plan. Risa Weinberger, Risa Weinberger & Associates, seconded the motion. The motion passed unanimously.

4. Next Steps – The RCC will vote to approve the Subcommittee’s conformance recommendation for the Fort Worth C&D Landfill at its next meeting on Wednesday, May 24, 2023. After this meeting, a letter stating the RCC’s final conformance determination will be submitted to TCEQ, and a copy will also be sent to the applicant.

PRESENTATION

5. Sonia Samir, P.E., Ph.D., Civil Project Manager, Parkhill, will brief the Subcommittee on the Type V MSW facility registration application for the BAP Kennor C&D Recycling Facility in Tarrant County.

Ms. Samir stated that the facility is currently active and located west of Fort Worth, about a half mile west of Lake Worth, on an unincorporated area of Tarrant County. The facility was permitted as a Type IV facility in 1980, but it stopped accepting waste in 1985. It changed ownership in 2022 and has applied for a Type V registration to be a recycling facility.

ACTION ITEM

6. The Subcommittee will discuss the Type V MSW facility registration application for the BAP Kennor C&D Recycling Facility, and vote whether to recommend to the Resource Conservation Council (RCC) that the application conforms to the North Central Texas Regional Solid Waste Management Plan.

There were several questions from the Subcommittee.

- 1) Are materials stored on-site within facility boundaries on a closed landfill?

No, the facility is just not accepting waste now.

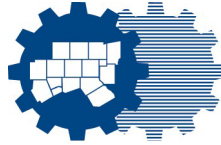
- 2) Who would be your first responder in case of an emergency?

The City of Fort Worth

- 3) Will this facility process vegetative waste or wood?

Yes.

Mike Friesen, North Texas Municipal Water District, made a motion to recommend to the Resources Conservation Council that the registration application for the BAP Kennor C&D Recycling Facility conforms to the North Central Texas Regional Solid Waste Management Plan.

Chris Hoofnagle, City of Garland, seconded the motion. Risa Weinberger, Risa Weinberger & Associates, abstained. The motion passed.

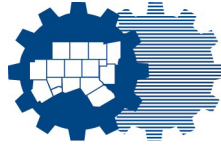
